MADAM/SIR:

An appointment has been made for you to have a visa interview with a consular officer. The date and time of this interview are indicated at the bottom of this page. Please read the following instructions carefully.

FIRST: Fill out in duplicate, but do not sign, the enclosed OF-156 together with the copy of the supplemental form attached (GNI-2). All questions on GNI-2 must be answered.

SECOND: COLLECT THE FOLLOWING ITEMS:

- 1. PASSPORT: You must have a passport which will be valid for at least 6 months beyond the date on which a visa is issued to you. You need a valid exit permit for travel to the United States. Each child sixteen years of age or older must obtain and present his own passport.
- 2. PHOTOGRAPHS: Obtain three color photos of yourself, following the instructions on GILV-1 and GIV-1A. Photos are required of all applicants.
- 3. MEDICAL EXAMINATION: Arrange for a medical examination, following the instructions on GIV-8. Each applicant must have a medical examination. Be sure to take to the hospital at the time of your examination the enclosed letter concerning your need for an examination, one copy of OF-157, and your passport.
- 4. BIRTH CERTIFICATE: Each applicant must have one notarized certificate of birth.
- 5. DIVORCE OR DEATH CERTIFICATES: If you were married previously, obtain one notarized certificate of marriage, and one notarized certificate of death or divorce to prove dissolution of the marriage.
- 6. UNMARRIED CERTIFICATE: You must provide a notarized certificate of unmarriage.
- 7. POLICE CERTIFICATE: Each applicant aged 16 years or over must submit a police certificate. If this certificate if unavailable to you because of a prior criminal conviction, you must obtain all available Court and Prison records. Police certificates are valid for one year.
- 8. EVIDENCE OF SUPPORT: Obtain evidence showing that you (and your children, if any) are not likely to become public charges while in the United States. The enclosed information sheet, OF-167, lists evidence which may be presented to meet this requirement of the law.

THIRD: All the documents mentioned above must be brought by you to your interview.

NOTE THAT NO ADVANCE ASSURANCE CAN BE GIVEN THAT A VISA WILL ACTUALLY BE ISSUED. YOU ARE STRONGLY ADVISED AGAINST GIVING UP YOUR JOB, DISPOSING OF PROPERTY, OR BUYING PLANE TICKETS UNTIL YOU ACTUALLY RECEIVE YOUR VISA.
